



Dear Parents,

Our school has an opportunity to access Title One funds through families who reside in the Berkshire Hills Regional School District (towns of Great Barrington, Stockbridge, West Stockbridge including the villages of Housatonic and Glendale) and the Southern Berkshire Regional School District (towns of Alford, Monterey, New Marlborough, North and South Egremont, Sheffield including the villages of Ashley Falls, Southfield, Mill River, Hartsville and Clayton). As a school, we can receive funds to help support our Educational Resource program.

In order to determine eligibility, families must fill out the enclosed form and return it to the school with their tuition assistance application. Eligibility is determined by size of family and gross income of the household (see chart below). Supporting documentation may be required. As always, all financial information will be kept confidential.
